Scholarship activity

With the help of our generous contributors, the Foundation continues to support the dreams of industry professionals by providing access to education through an expanding scholarship program. Just 13 years ago, in 2010, the Foundation awarded 85 scholarships. We are thrilled to share how much the Foundation has grown since then.


